The BFI Capital Group is a well-established Swiss asset manager with \$1 billion in assets, and more than 30 years of experience in wealth services, strategies and solutions.

The AltAlpha Digital Fund provides professional and institutional investors access to a well curated portfolio of token / crypto investment managers within an institutional grade setup. The fund diversifies its underlying investments across managers, strategies, and investment themes to create a holistic and risk adjusted portfolio. The investment committee scans the global fund landscape and leverages its personal network, scouting for the best talent and most effective strategies in the industry. The battle tested due diligence process for fund selection is a combination of BFI's decades of experience in managing funds in traditional finance world, infused with the unique experience set of the investment committee members within the new digital realm.

The AltAlpha Digital fund launched with an early investor share class, offering professional investors strongly reduced fees of a 0.5% management fee p.a. and 5% performance fee p.a. starting at USD 100'000. This fund is globally available, also be for US investors.

This regulated Professional Investor Fund (SICAV) has been set up with Julius Baer as custodian and Deloitte as auditor. The fund manager, BFI Consulting, operates under Swiss law, while the fund company, AltAlpha Strategies, operates out of Malta. Both jurisdictions have led for years with their positive and constructive approach towards the digital asset space, providing regulatory clarity and guidelines.
